GOVERNOR SEYCHELLES ( PERSONAL)

1. HEADLINED QUOTE DISTRESS OF REFUGEES FROM PEROS BANHOS, DIEGO APPLA AND AGALAGEA UNQUOTE LE MILITANT, JOURNAL OF THE MMM REPORT ONVERSATION BETWEEN BERENGER AND GUY OLLIVRY WITH JOURNALISTS YESTERDAY DEPLORING THE TREATMENT OF MAURITIUANS FROM ABOVE ISLANDS WHO ARE IN DISTRESSED STATE, TORM FROM THEIR COUNTRY OF ORIGIN. EXPRESS ALSO CARRIES SAME STORY.

2. BERENGER HAS RECEIVED LETTER FROM SERVINAL, SECRETARY OF SPUP, INFORMING HIM THAT 146 PEOPLE HAVE JUST BEEN REMOVED FROM DIEGO GARCIA DESTITUTE AND ARE IN TRANSIT AT SEYCHELLES ON WAY TO MAURITIUS. SERVINAL STATES THAT THE MAURITIAN ILOIS HAVE BEEN LODGED IN PRISON. BERENGER MAKES FOLLOWING OTHER POINTS:

A. THESE ARE THE LAST BATCH OF REFUGEES, OTHERS WHO WERE DISPLACED BEFORE HAVE RECEIVED NO FORM OF COMPENSATION OR HEAETILEHERT BEHEFIT

B. THERE ARE SOME 300 FAMILIES IN MAURITIUS IN UTTER DISTRESS. MOST OF THOSE ILOIS ARE IN MAURITIUS: BUT THERE ARE SEVERAL IN SEYCHELLES. 351

C. THE MAURITIUS GOVERNMENT SOLD DIEGO GARCIA FOR £3M AND THESE UNFORTUNATES TORN FROM THEIR NATIVE COUNTRY HAVE RECEIVED NOTHING.

D. ILOIS MOSTLY EMPLOYED BY CHAGOS AGALEGA LTD( AFFILIATED TO ROGERS £AND CO) WERE PROMISED A COMPENSATION OF RS 500, BUT THIS HAS NOT MATERIALISED.

3. BERENGER STATES THAT HE INTENDS TO RESOLVE THIS PROBLEM AND WILL DEMAND FROM ALL CONCERNED NAMELY MAURITIUS GOVERNMENT, THE BRITISH AND AMERICAN GOVERNMENTS AND THE COMPANIES WHO EMPLOYED THEM, ADEQUATE COMPENSATION FOR THESE ILOIS. MAURITIUS, IN COMMON WITH CEYLON, INDIA AND AFRICAN LITTORAL COUNTRIES DOES NOT WANT THE MUCLEARISATION OF THE INDIAN OCEAN.

BERENGER ALSO STATES THAT A FEW OF THESE LAST IN HABITANTS

- TOT SEEING THAT EXPULSION WAS IMMINENT APPEALED TO PARUL MOULINE AND THAT LATTER HAD PROMISED THEM RS 500 WHICH HE NOW DENIES. THEY WERE GIVEN CHOICE OF TRANSFER TO PEROS, AGALEGA OR SALOMON OR REPATRIATION TO MAURITIUS OR SEYCHELLES BUT THAT. UNWILLING TO WORK FURTHER FOR HIS COMPANY ON ACCOUNT OF THEIR HARSH ATTITUDE THEY CHOSE REPATRIATION. IN OCTOBER 146 PEOPLE WERE EMBARKED ON - NORDVAER- AND SENT TO MAHE. THE SEYCHELLOIS WERE ACCOMPDIATED WITH RELATIONS BUT THE QUOTE CREOLES UNQUOTE OF THE ISLANDS WERE LODGED IN PRISON. THESE WILL BE' IMMEDIATELY EMBARKED ON THE - MAURITIUS- FOR RETURN TO MAURITIUS WHERE THEY WILL DOUBTLESS SWELL THE RANKS OF THE UNEMPLOYED. ABOUT 200 PEOPLE WILL SOON BE REPATRIATED TO MAURITIUS. ALL THESE WORKED FOR THE "AGOS AGALEGA COMPANY. THEIR MAIN DEMANDS ARE- PAYMENT OF BONUS A. L. JI BAGED IN THEIR CONTRACT, COMPENSATION PAYMENT FOR EXPULSION. 5. BERENGER ENDS BY STATING THAT IT IS UP TO THE BRITISH HIGH COMMISSION, IN VIEW OF BIOT BEING UNDER BRITISH SOVEREIGHTY TO FURNISH SATISFACTORY AND REASONABLE HELP FOR THESE RECENT VICTIMS. OF IMPERIALISMA
  - 6. GRATEFUL FOR EARLIEST COMMENTS AND STATEMENT OF TRUE POSITION.
    IN ANSWER TO PRESS ENQUIRIES WE ARE SIMPLY SAYING THAT WE HAVE
    SOUGHT CLARIFICATION FROM YOU. I HAVE RECEIVED NO ENQUIRY FROM
    MAURITIUS GOVERNMENT. GOVERNOR SEYCHELLES SHOULD KNOW THAT
    BERENGER IS NOW IN A FAR STRONGER POSITION TO MAKE TROUBLE.
    7. FCO PLEASE PASS IMMEDIATE PERSONAL GOVERNOR SEYCHELLES.
