# Alumni Profiles

# Jon Menaster, IER '10



Jon lives in fashionable Brooklyn and works as a senior analyst for the <u>Government AccountabilityOffice</u>. The GAO performs financial and performance audits of federal government programs, and Jon specializes in the latter. "We examine the performance of particular programs, and the audit can be quantitative or qualitative in nature. I work in the <u>FinancialMarketsandCommunityInvestment</u> group, and we have responsibility mainly for government programs in banking, securities, insurance and housing. This means we help to oversee programs run by the Treasury, the Fed, the SEC, Fannie Mae/Freddie Mac, and the like." He has been with the GAO for six years now, initially based in Washington, DC.

"We operate like a private-sector consulting firm: we design our project and determine the scope and methodology required to answer the researchable questions, then we carry out the actual research, and later we use the results to compare what the agencies are doing against standard criteria of how best to operate a government program. This helps us decide what recommendations would make sense in any given situation."

On what skills, background and experiences have proven useful in the job market and his career path, Jon explains that his prior experience in the private sector, before graduate

school, was helpful because he learned how to work with a diverse group of people on large projects. His experience in graduate school, for its part, helped him hone his research and data-analysis skills, as well as to gain subject-matter expertise in financial institutions, markets and policies.

To be a successful project manager and to get hired as such, especially within the government, you need a strong background in both research and writing as well as in oral communication skills. The best research won't matter if you can't write clearly; the best ideas for designing a research project won't matter if you can't communicate them to your team; and the best first draft won't matter if you don't learn to incorporate feedback from colleagues and superiors."

Regarding his time in the IER program and on what proved useful in developing his career, Jon recalls as follows: "I entered the IER program with very limited research skills, and I believe the wide variety of classes I took both within SIS and in the Economics Department helped me to rapidly gain key qualitative and quantitative research skills that have proved invaluable over time."

"I also did two things outside of IER that were very important to my overall development. First, I ran for and was elected president of the SIS Graduate Student Council, and this helped me to network with many students outside of IER, which I think is important to help contextualize the education you're receiving. The position also helped me learn valuable communication and presentation skills."

"Second, I joined other IER students and we competed -- and won! -- in the Annual Kogod Case Competition, which provided an excellent opportunity to sharpen our communication skills, presentation style, and problem-solving techniques. The competition not only helped me apply analytical skills and become a well-rounded person and job candidate, it was an excellent story to tell during job interviews."

Kirstin Schloss Murray, IER '11



Kirstin is Bank Examiner for Capital Markets at the Washington, DC, headquarters of the Office oftheComptrolleroftheCurrency (OCC), which is part of the U.S. Treasury and charters, regulates and supervises all national commercial and savings banks, as well as the agencies of foreign banks.

Her <u>CapitalMarkets</u> area monitors the interest rate, liquidity and price risks faced by the nation's largest banks, ensuring that the banks are complying with regulations — in particular, the new ones under the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010. "In order to supervise our banks," Kirstin says, "we maintain close contact with bank management through regular meetings, and we review their daily, monthly and quarterly reports. We also assess their risk-management practices and review their policies.

Asked about what current events in international economic relations interest her most, Kirstin replies that "one area I find particularly thought-provoking is how different regulations affect our banks' business models. It is quite a global challenge for banks to operate in multiple jurisdictions when countries have adopted different prudential and other rules for banking, thereby creating legal, compliance, operational and business complexities for banks and their regulators alike.

On what skills, background and experiences have proven useful in the job market and her career path, Kirstin offers that "I have found that programming, analysis, attention to detail, and ability to ask questions have been the most important skills in my job. It has also been very important to recognize how financial markets affect our banks' balance sheets

and activities, and my IER concentration in international finance provided me with the foundation for understanding the links between financial flows, interest rates and exchange rates."

Kirstin also recalls the importance of having landed good internships: "The single most valuable experience during my graduate program was my internship with the OCC. Not only did it solidify my understanding of international finance, but it also led to my current job."

On how she was attracted to the field of international finance, Kirstin remembers that "at the start of the IER program, I was unsure if I wanted to focus on international trade or finance. To gauge my interest in trade issues, I applied for and obtained an internship with the International Trade Administration, in the Department of Commerce. While I enjoyed the internship, I quickly realized that I was much more passionate about financial issues, and so for my second internship I purposely targeted the International Analysis group at the OCC. Therefore, my advice is that IER students should use internship opportunities strategically, to help them decide which area of concentration, and eventually which career, is best for them."

Kirstin also offers the following advice: "Networking is huge in any job field, but it's not just networking for the sake of networking. I've found that the best type of networking comes from working on cross-functional teams, where the members help one another. People are then able to understand what one brings to the table. Internships are a great way to network, build valuable skills, and better understand one's passion. Technical skills are very important too. For me, SAS/STATA programming combined with econometrics has been key."
